



*The House passed H.R. 2575 in April 2014 to change the Affordable Care Act's definition of a full-time employee from 30 hours to 40 hours. Both Chambers introduced bills in the summer of 2014 (H.R. 5213 and S. 2881) to clarify the Affordable Care Act's definition of a seasonal employee.
