

### FRESH PERSPECTIVES ON POLITICS, GOVERNMENT

#### **AND YOUR ROLE AS A CITIZEN**

#### **DR. JOE BISCHOFF**

Dr. Joe Bischoff is one of SAF's lobbyists with Cornerstone Government Affairs, a firm specializing in government relations, strategic consulting and advocacy. He joined the agriculture and natural



resources team at Cornerstone Government Affairs following his work in government and regulatory affairs for the horticulture industry where he focused on the intersection of federal programs and science-based solutions to plant health and crop production challenges. Dr. Bischoff has served on a number of scientific committees and review panels including the National Invasive Species Council's Invasive Species Advisory Committee (ISAC), National Clean Plant Network (NCPN) and the National Institute of Food and Agriculture (USDA-NIFA). Previously, Dr. Bischoff was with the USDA's Animal Plant Health Inspection Service (APHIS) where he was National Mycologist and Lead Scientist on the APHIS Intercepted Plant Pathogen Sequence Initiative (IPPSI).

#### **CHRIS CILLIZZA**

By uniquely viewing politics as a "theatre," or an endless drama of opposing forces, Chris Cillizza now stands as one of Washington's most exciting analysts of campaign politics. With both



humor and probing insight, the self-described political junkie speaks to a variety of audiences with great clarity on the nuances of national and local campaign politics. His extensive media appearances, spanning from TV to print to the blogosphere, have led *The Washingtonian* to name him one of the top 50 journalists working in Washington today. Cillizza seamlessly uses his immense reservoir of political knowledge to examine the past and provide insights on the constantly evolving state of Washington politics. His commentary additionally explores the meaning of the current presidency with prodigious depth and a discerning eye for future political trends.

#### **SHAWN MCBURNEY**

Shawn McBurney is a lobbyist and joined SAF in 2015 as senior director of government relations. He represents the floral industry on Capitol Hill on issues that impact the broader SAF mem-



bership, such as health care, immigration reform, taxes, minimum wage, overtime and other labor issues. McBurney has worked in the government relations arena since 1993 with positions on Capitol Hill, in the federal government, a non-profit and a trade association.

Andrew Och is an awardwinning television and multi-media producer who has traveled the world with his pen, paper and camera. A storyteller from a young



age, Och enjoys the art of communication, and will go anywhere in the world for more knowledge, greater understanding and a good story. For the C-SPAN series, "First Ladies: Influence and Image," Och spent over a year traveling to nearly every location that helped tell the stories of every First Lady of the United States. He covered Martha Washington through Michelle Obama. Historians, archivists and enthusiasts agree: Och's project and travels put him in a small and rare group of people. He is responsible for one of the most complete and vast collections of material and information about this unique sorority of women ever assembled. He is the First Ladies Man, and he is excited to share the stories of his adventures. Och is the author of Unusual For Their Time.
