**SHIPPING INSTRUCTIONS
FOR PERISHABLE DONATED PRODUCT
FOR PREMIER PRODUCTS SHOWCASE**

Armellini Express Lines has graciously agreed to assist SAF in shipping perishable product to the SAF convention for Premier Products Showcase. Please make careful note the deadline dates and shipping instructions to ensure that all items arrive on time. Make sure that all fresh product is ice packed in flat boxes, placed in insulated boxes, or proconas. Please read through everything carefully.

Shipping from Miami: Local and imported product arriving through Miami only:

1. All shipments through Armellini must have on the Bill of Lading stating:

2. **All product must be received no later than NOON on Sunday, September 2** at Armellini's terminal. Armellini Express Lines is located at:

All boxes should be packed in accordance with normal guidelines used by Armellini Express Lines (SAF Palm Springs 2018 Premier Products Showcase on label, and all boxes labeled when necessary), with a PREMIER PRODUCT SHOWCASE PINK STICKER (enclosed) prominently placed and an invoice of what is attached.
