**Instructions:**

Read instructions carefully before filling out nomination form.

1. Please print legibly or type nomination form.
2. Be as accurate and factual as possible. Wherever there is a question of accuracy (dates, for example), always qualify with "about" or "approximately" but use these only when necessary. **DO NOT** use alphabetical abbreviations.
3. **DO NOT** duplicate. If you include information in one place, do not repeat it elsewhere.
4. If extra space is needed, attach additional sheets identifying the number of the corresponding question to which the information relates.
5. Recheck all items on the nomination form carefully before mailing. Make sure all items are accurately and completely filled in before returning.
6. Attach a black/white photo of the nominee if available.
7. **DO NOT** attach exhibits of any kind. The Awards Committee will write to you if further information of this type is required.

**Special note:** Please study the entire nomination form before you complete it out. Care in filling out the information required is of extreme importance. Incomplete or inaccurate recording of facts frequently causes undue delay and disappointment. Please keep in mind that the information requested is kept confidential.
